

TORONTO'S WATER SUPPLY.

Disseminated by Dr. J. J. Cassidy before the Provincial Health Officers.
GUILTY, June 27.—The eighth annual meeting of executive health officers of Ontario opened in the city yesterday morning.

The following papers were read at the day's meeting: "Diphtheria Epidemics" by Dr. A. Hodgson of Toronto; "The Sanitary Conditions of Ontario" by Dr. J. J. Cassidy, Ontario's Provincial Health Officer.

Dr. Cassidy said in his report that the present water supply of Toronto is deficient with sewage is acknowledged, that it is likely to continue for some years, and that there is no good reason to think that any important improvement will be effected in the immediate future.

Many plans might be devised by which the defects could be remedied. For instance, a tunnel could be driven from the city extending from the pumping-house three miles out into Lake Ontario.

For present needs and for many decades to come a six-foot tunnel supplying 72,000,000 gallons of Lake Ontario water would be ample. It projected from sewage pollution the quality of the water ought to be excellent.

If for financial or engineering reasons a tunnel cannot be built filtration of the present supply of water is the only method of obtaining a water of good quality at a small outlay.

There is yet another plan. The York Waterworks Company is now prepared to offer the city of Toronto an abundant supply of pure water at a rate of one cent per 100 gallons.

The company's principal location is in the highlands, about two miles north of the city limits. This property is on the crest of a hill, the ground falling away on all sides.

Beneath the layer of surface clay there is a bed of water-bearing sand. The water in this sand already made satisfactory provision at this point, a conclusion reached by the fact that there is one well in the locality supplying the Toronto Hotel with 200,000 gallons per day.

The reasons for this dividing the supply are: 1. Because the proposed tunnel construction made it possible to divide the supply into two parts.

The first case taken up was that of Miss Mary Jane Organ of 96 Peter-street against the City of Toronto, Margaret O'Grady, owner, and James O'Donoghue, tenant of the Shakespeare Hotel.

Organ, who is a fur-wearer, was on January 18 last, slipped on a ridge of ice formed by an overflow of water from a pipe on the hotel. Her right wrist was broken and she was otherwise injured.

The city claims that Miss Organ and the owner of the hotel were responsible. Miss Organ testified that she went to St. Michael's Hospital, where the wrist was set by Dr. Roche about four hours after the accident.

For the plaintiff Irwin & Kyle appeared, for the city Mr. Biggar and for O'Donoghue Mr. D. O. Cameron and Mr. W. N. Miller for Mrs. O'Grady.

After the evidence was given the jury was taken to the scene of the accident. The case was not concluded.
