

Order in Council P.C. 3492, dated November 10, 1939: authorizing medical care, etc., to Canadian salt-water fishermen.

Order in Council P.C. 3495, dated November 7, 1939: authorizing Industrial Disputes Investigation Act to apply to Government War Contracts.

Order in Council P.C. 3523, dated November 7, 1939: authorizing employment of Mr. F. Campbell Cope, Advocate, by the War Supply Board, with a living allowance of \$15 per diem.

Order in Council P.C. 3524, dated November 7, 1939: authorizing employment of Mr. J. P. Macfarlane, K.C., Barrister, by the War Supply Board, with a living allowance of \$15 per diem.

Order in Council P.C. 3525, dated November 7, 1939: authorizing employment of Mr. R. H. Littlejohn, Barrister, by the War Supply Board, with a living allowance of \$15 per diem.

Order in Council P.C. 3526, dated November 7, 1939: authorizing employment of Mr. K. B. Palmer, Barrister, by the War Supply Board, with a living allowance of \$15 per diem.

Order in Council P.C. 3527, dated November 7, 1939: authorizing the employment of Mr. G. C. Papineau-Couture, K.C., Advocate, by the War Supply Board, with a living allowance of \$20 per diem.

Order in Council P.C. 3531, dated November 7, 1939: requiring stiffening in Canadian ships.

Order in Council P.C. 3532, dated November 7, 1939: authorizing issue of licences for export of fibre flax seed.

Order in Council P.C. 3556, dated November 9, 1939: authorizing Department of National Defence to lease accommodation for Naval, Military and Air Forces.

Order in Council P.C. 38/3571, dated November 9, 1939: allocating the sum of \$150,000 to the National Research Council for the purpose of employing temporarily such scientific, technical and other staff as it may find necessary from time to time, to assist industry in the solution of problems relating to Canada's war effort.

Order in Council P.C. 77/3571, dated November 9, 1939: providing protection to ex-members of the Royal Canadian Mounted Police who are civil servants and who re-engaged for service during the present war, as regards leave of absence, superannuation, statutory increases, etc.

Order in Council P.C. 89/3571, dated November 9, 1939: allocating the sum of \$20,000 to the Department of Pensions and National Health for investigations respecting Dependents' allowances.

Order in Council P.C. 3572, dated November 9, 1939: authorizing the issue of licence to a trawler of French registration.

Order in Council P.C. 3607, dated November 14, 1939: amending Order in Council P.C. 3042, dated October 11, 1939, respecting the use or possession of firearms, etc., by enemy aliens.

Order in Council P.C. 3613, dated November 23, 1939: issuing two trawler fishing licences to General Seafoods, Limited, of Halifax, N.S.
