STARRED QUESTIONS

WINTER WORKS PROGRAMS, INDIAN BANDS

Question No. 21-Mr. Howard:

1. What is the name of each Indian band with which the government (a) has agreements; (b) is in discussion with, regarding participation in municipal winter works incentive program?

2. With respect to each project to be undertaken by each such band, what is (a) the amount of money to be contributed by the federal govern-ment; (b) the amount of money to be contributed by the band?

Hon. Michael Starr (Minister of Labour): Mr. Speaker, the answer to the first part, (a), is none; the answer to (b), is as follows. Through arrangements with the Department of Citizenship and Immigration, the Indian affairs branch of that department has recently circularized all Indian bands advising them of the terms of the municipal winter works incentive program and inviting applications. It is anticipated that applications from Indian bands will be received in the near future.

Hon. Leon Balcer (Solicitor General): I wonder if the hon. member would allow this guestion to stand, because it involves information which has to be secured from the United States, and it would inevitably take a little time before a complete answer can be given to this question.
