# Proposed Legislation COMPANY DIRECTORS

BOARDS OF FEDERAL COMPANIES TO HAVE MAJORITY OF CANADIANS

Mr. E. J. Broome (Vancouver South) moved for leave to introduce Bill No. C-59, respecting company directors (directors' qualifications).

Some hon. Members: Explain.

Mr. Broome: The purpose of this bill is to require that all companies created by the parliament of Canada be managed by a majority of directors who are either Canadians or Canadian residents.

Motion agreed to and bill read the first time.

#### REPRESENTATION ACT

AMENDMENT TO CHANGE NAME OF CONSTITUENCY

Mr. R. S. MacLellan (Inverness-Richmond) moved for leave to introduce Bill No. C-60, to amend the Representation Act.

Some hon. Members: Explain.

Mr. MacLellan: The purpose of this bill is to change the name of the constituency of Inverness-Richmond to Inverness-Richmond-West Cape Breton, as the electoral district includes part of the county of Cape Breton as well as the counties of Inverness and Richmond.

Motion agreed to and bill read the first time.

### CANADIAN WHEAT BOARD

PROPOSED LEGISLATION RESPECTING CONSTITUTION AND POWERS

Mr. J. N. Ormiston (Melville) moved for leave to introduce Bill No. C-61, to quieten doubts that have arisen concerning the constitution of and the exercise of powers by the Canadian wheat board and for the resolving thereof (Canadian wheat board).

Some hon. Members: Explain.

Mr. Ormiston: The purpose of this bill is to make an effort to obtain clarification of the powers of the Canadian wheat board to grant or withhold licences to ship grain interprovincially. The remedy suggested is a reference to the Supreme Court of Canada for delivery of the judicial opinion, is the possible transfer of the issuance of such licences from the wheat board to the Minister of Agriculture, who will be accountable to parliament to the house, it is his privilege to reply. with respect to the granting and review of such licences.

## EXPORT CREDITS INSURANCE ACT

AMENDMENT RESPECTING MAXIMUM LIABILITY OF IMPORTERS

That it is expedient to introduce a measure to amend the Export Credits Insurance Act to increase the maximum liability at any time of importers outstanding instruments the payment of which is guaranteed by the corporation under section 21A of the act, from \$200,000,000 to \$300,000,000; and to provide further for a certain change in connection with the administration of the act.
