REPORTED TAKING OF PENSION INCREASE BY HOMES FOR AGED

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, may I direct a question to the Minister of National Health and Welfare. In view of reports of homes for the aged in Ontario and in Manitoba taking most or all of the \$10 pension increase recently provided by parliament in higher rents, will the government see what can be done to protect our old age pensioners against this practice?

Hon. Judy V. LaMarsh (Minister of National Health and Welfare): As my hon, friend knows, the federal government in bringing about the increase in the old age pension had hoped it would be passed to the pensioners to alleviate some of their need. It has been disturbing to notice in the last couple of days that in various provinces this amount is not being passed to the pensioners. While this decision appears to lie within provincial jurisdiction, my hon. friend may be assured that whatever can be done will be done by the federal government to encourage the passing on of this money to the pensioners.
