Mr. McIlraith: I had one here last night.

Mr. Churchill: Then why didn't we?

Mr. Starr: Again on my question of privilege. Mr. Speaker, the minister seems to have had a bill which is not yet printed, but he has it in some form or other. No one else has a copy of the bill which he says was available. Available to whom?

Mr. McIlraith: It was available in the house at the table.

Mr. Starr: It was not. Again I raise a question of privilege, Mr. Speaker. I have checked with the table and it appears the bill was not available at the table.

Mr. McIlraith: I should just correct the hon, gentleman on the procedure. I do not know the numbers that were available; it may well be that insufficient copies were supplied. When a resolution is passed the usual procedure—though it was deviated from four or five years ago on two or three occasions—is to have limited first printing. I think the number is 25, but I will verify that and find out the exact number. Then when the bill is given first reading, a pro forma reading, the required number for total distribution is made available, and those copies are usually available the next morning.
