##### SUMMER LANGUAGE PROGRAM—DECISION AS TO ADMINISTRATION

**Mr. John L. Skoberg (Moose Jaw):** Mr. Speaker, my question is directed to the Secretary of State. In view of the minister's statement today concerning the Opportunities for Youth program, or the results of that program, and in light of the fact that universities have closed or will be closing at the end of this month, can the minister say whether there has been a final decision as to who will administer the second language exchange program involving 2,500 students?

**Hon. Gérard Pelletier (Secretary of State):** Mr. Speaker, I am not sure I know what the language exchange program is. I know of no program by that particular name. It might be bursaries for the study of a second language or the member might be referring to the travel and exchange program. There exists no such thing as a language exchange program. Therefore I do not know exactly what the hon. member is talking about.

**Mr. Skoberg:** Mr. Speaker, the phrase I used was "the second language exchange program" as referred to by the minister in Winnipeg when he announced the Opportunities for Youth program. If he is not aware of what I am referring to, perhaps he could indicate whether there has been any determination as to who will administer the program involving 2,500 students inasmuch as there has been no decision up to this time regarding how they should apply or who will accept applications.

**Mr. Pelletier:** Once again, Mr. Speaker, I do not know what the hon. member means by a "language exchange program" which would involve 2,500 students. In fact, there are exchange travels through Canada which

involve about this number of people and there are language courses which concern only 1,500 people.

The announcement I made dealt with one or the other of these programs. If, then, these are language courses, they are administered in co-operation with the Canadian council of education ministers; the travel exchanges are directly administered by the Secretary of State.
