Mr. Orlikow: Mr. Speaker, when the survey is being conducted are the people of whom questions are asked told the questions are in respect of a survey being conducted by the minister's department?

Mr. Munro: Mr. Speaker, those attending the seminar held at the inauguration of the study consisted of team leaders, 32 in number, who were all graduate students, mostly graduates in sociology. They were brought to Ottawa and told that the students they had in their teams to conduct the survey should let it be known that they were not peeping toms, that they were not conducting something in secret and that they should identify themselves.

Mr. Woolliams: Mr. Speaker, just to clear the air, could the minister assure us that no young person being employed by the government in this or any other government sponsored service is being fingerprinted?

Mr. Munro: I can speak only for this particular study.

Some hon. Members: Hear, hear!

Mr. Munro: I am not aware of this having taken place, in reference to this study, nor am I aware of it having

AIR CANADA

TROIS-RIVIÈRES-DISCONTINUANCE OF SERVICE

Mr. René Matte (Champlain): Mr. Speaker, I have a question for the Minister of Transport.

Is he aware of Air Canada's intention to discontinue its air service at Trois-Rivières and, if so, does he intend to intervene personally in order to prevent this?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, I have been advised in the normal way of the intention of Air Canada. As for interventions, they can only come at the appropriate time, which would be following a decision by the Canadian Transport Commission. If the ultimate decision is not satisfactory to certain parties, as I recall it they have the right of appeal to the minister.
