When does the minister expect to table the report of the advisory inquiry committee established last April.

PROPOSED MACKENZIE VALLEY PIPELINE—REASON FOR FAILURE TO MAKE CANADIAN POSITION CLEAR TO UNITED STATES

Mr. Peter Bawden (Calgary South): Mr. Speaker, I have an additional question for the Minister of Energy, Mines and Resources on the subject of the pipeline from Alaska. Last April he said repeated attempts had been made to inform Washington of the government's position with regard to this oil pipeline. Can the minister say why he is finding so much difficulty in communicating with Washington and whether he anticipates he will now be able to make our position clear as it relates to an oil pipeline through Canada.

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Well, Mr. Speaker, as I have stated, our position has been communicated both to the United States State Department and the Secretary of the Interior and, indeed, to members of both the Senate and of the House of Representatives when they were in Ottawa.

#### Oral Questions

Mr. Oberle: On a point of order, Mr. Speaker. I had occasion to visit Washington in April of this year and I would hate to see the Secretary of State for External Affairs have the last word on this subject. He has said that the Senate and Congress of the United States were aware, and that the House was aware—

Mr. Speaker: Order. The hon. member knows, or ought to know, that this is not a point of order. If he can show me, by reference to the Standing Orders, how an intervention of that kind is a point of order I will be pleased to hear him further.

Mr. Oberle: Mr. Speaker, the point of order is that the Secretary of State for External Affairs has said that the position of the government was made clear to the House of Commons, to the people of Canada and to the Senate and Congress of the United States. That is very difficult for me to believe.

Mr. Speaker: The hon. member can believe or disbelieve what is said in the House by other hon. members but that has nothing to do with the Standing Orders of the House of Commons.
