Does the government subsidize the Canadian Council on Social Sciences Research and, if so (a) for how many years (b) through what department (c) what amounts were granted in 1971, 1972 and 1973 (d) did the government make a grant as capital for the Council at the time it was created or at some later stage of its development?

Hon. James Hugh Faulkner (Secretary of State): (a) The Canada Council has subsidized the Social Science Research Council since the fiscal year 1957-58. (b) Not applicable. (c) The figures available to the council are for fiscal years ending March 31: 1971-72, \$347,468; 1972-73, \$465,412; 1973-1764, \$522,961. (d) No.

The Staff of the National Energy Board includes 36 employees who have training in economics, ecology or environment and who occupy positions classified accordingly within the Scientific and Professional category. Several other employees of the Board have also had training relative to the aforementioned fields but fill positions in other occupational categories. Consequently, a large, complex amount of work would be required to identify each such individual and provide an accurate return.

INTERLOCKING DIRECTORSHIPS

Question No. 207-Mr. Herbert:

Is the government considering the reintroduction of legislation to prohibit interlocking directorships where it is satisfied that such interlocking directorships have or are likely to have the effect of significantly lessening competition?

Hon. André Ouellet (Minister of Consumer and Corporate Affairs): The government is proceeding with the revision of competition policy in two stages. Bill C-2 represents the first stage. In the second stage, consideration will be given to the reintroduction of legislation relating to interlocking directorships.

VETERANS IN THE OKANAGAN BOUNDARY IN RECEIPT OF ALLOWANCES

Question No. 302-Mr. Whittaker:

- 1. What is the estimated number of veterans in the Okanagan Boundary receiving (a) war veterans allowance (b) disability pension (c) civilian war allowance?
- 2. Under the Veterans' Land Act, if both husband and wife are veterans, does the certification of one signify the eligibility of the other?

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): 1. Statistics are not maintained by the census division on the numbers of veterans receiving War Veterans Allowance, Civilian War Allowance and Disability Pension. According to the 1971 census, there were an estimated 3,435 veterans resident in the Okanagan-Similkameen census division. This represents 3% of the estimated veteran population of the department's Vancouver district office. At August 31, 1974, in this district, there were 6,237 persons in receipt of War Veterans Allowance and Civilian War Allowance and 15,075 veterans in receipt of disability pension.

2. No. It was necessary for a veteran, on an individual basis, to apply for and be certified as qualified on or before October 31, 1968.
