## **AGRICULTURE**

WESTERN FARMERS' TRANSPORTATION COSTS

Mr. Lee Clark (Brandon-Souris): Madam Speaker, while farmers, particularly those in the West, are struggling just to survive, the federal Cabinet may actually approve a proposal which would serve to worsen the prairie producers' financial bind. As though it were not enough to propose huge increases in rail transportation costs over the next three years, the Government may now increase the cost of moving grain and other commodities along the St. Lawrence Seaway. Any such rate increase would be paid largely out of the pockets of prairie farmers. But these people absolutely cannot tolerate any further financial burdens.

Let me remind this House of the transportation costs western farmers already face. Collectively, farmers pay about \$150 million each year to move their grain by rail. Under the Western Grain Transportation Act they will be compelled to pay an additional \$219 million over the next three years. Add to that the \$24 million which farmers currently contribute toward St. Lawrence Seaway tolls. Even a 5 per cent increase, which is within the Government's restraint guidelines, is asking too much. Indeed, Canadian farmers must be asking themselves where it will all end. Unfortunately for some of them it will end in bankruptcy, unless the Government wakes up to the serious financial problems facing Canada's farmers.

Mr. de Corneille: Why then has our Department of External Affairs not moved in the past to condemn the presence of the parasite PLO in Lebanon and the Syrian invaders, and demanded the withdrawal of Syria and the PLO? Why is the double standard now once again applied against Israel? Condescending statements are made castigating Israel for its presence in Lebanon, and calling upon Israel to withdraw unilaterally from Lebanon. Madam Speaker, such an unfair, unrealistic, and bankrupt policy is a disgrace.

ADVERTISING CAMPAIGN TO PROMOTE ENERGY EFFICIENT HOMES
