REQUEST TO WITHDRAW TARIFF ON ENGLISH LANGUAGE BOOKS

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, I have the honour to present several petitions concerning the imposition of a retaliatory tariff on imported books in the English language which has limited the access of Canadians to literature and information. The tariff has little negative effect on the publishing industry of the United States but penalizes Canadian consumers, book publishers, book sellers and distributors and Canada's culture. Rising book prices have placed a strain on the acquisition programs and policies of our nation's public and specialized libraries.
