Q.C. 11 Oct., 1880. Is a D.C.L. of Bishop's College, Lennoxville, 1883. Has been Mayor of the Tp. of Brome, and Warden of the County of Brome. Was editor of the *Observer* (Cowansville) for a short period, and has twice held the Presidency of the Provincial Asso. of Protestant Teachers of Quebec. Sworn of the Ex Council and apptd. Solicitor-General 30 Oct., 1879. On the abolition of that office, 31 July, 1882, apptd. Commr. of Crown Lands. Resigned 20 Jan., 1887. Was Commr. Crown Lands in the Taillon Administration, from 25 Jan., 1887, until it resigned 27 Jan., 1887. First returned to Leg. Assem. by acclamation at g.e. 1871; re-elected by acclamation at g.e. 1875; at g.e. 1878, again in Nov., 1879, on his being apptd. Solicitor-General, and at g.e. 1881 and 1886. MARCHAND, *Lieut.-Col., Hon. FELIX GABRIEL* (*St. John's.*)

S. of Gabriel Marchand, who came from Quebec in 1802; and settled in St. John's. B. there 9 Jan., 1832. Ed. at St. Hyacinthe Coll. Admitted a Notary in 1855. M. 12 Sept., 1854, Miss Marie Hersélie Turgeon. Founded and was for several years editor and proprietor of *Le Franco-Canadien* newspaper. Elected a mem. of the Executive of the Reform Asso. of the Parti National of Montréal, 1875. Holds from the Government of France the decoration of Officer of Public Instruction. Is author of *L'Erreur n'est pas compte*, *Les Faux Brillant*, *Fatenaille*, and of several other dramatic pieces in verse and prose. Was Lieut.-Col. commanding 21st Batt. Richelieu Light Infantry. Commanded a Brigade at the front during the Fenian excitement in 1870. Sworn of the Ex. Council and apptd. Provincial Secretary 8 March, 1878, which office he held until apptd. Commr. of Crown Lands, 19 March, 1879. Resigned 30 Oct., 1879. Elected Speaker of Leg. Assem. 29 Jan., 1887. First returned to Leg. Assem. at g.e. 1867; re-elected by acclamation at g.e. 1871; g.e. 1875, g.e. 1878, and g.e. 1881, by acclamation. Re-elected at last g.e. after a contest. A Liberal.—*St. John's, P.Q.*
