The Prisoners Arraigned and Plead Not Guilty.

Their Trial Begins This Afternoon-Chief Justice Meredith's Remarks to the Jury.

ST. THOMAS, March 6.- The attention of the court has been taken up today with civil cases, and it is not likely the case of the Queen vs. Hendersott and Welter will be reached before tomorrow afternoon.

It is rumored that the Crown have lately secured very damaging evidence particularly against the prisoner Welter. A large number of expert medical witnesses are here from Toronto and other places. The city is fast filling up with jurors, witnesses and parties from the surrounding country anxious to hear the trial.

In his address to the grand jury, speaking of the Hendershott murder, Chief Justice Meredith said that it was not necessary for a person to be present at a murder to be guilty of the crime. There may be a promoter and an actor, and the one who procured the other to commit the murder is just as guilty as though he committed it himself.

The first case taken up by the court was an action for damages for injuries received, brought by Robert Ferguson against the Townships of Southwold and Yarmouth.

TRUE BILL IN THE HENDER-SHOTT CASE.

A true bill was brought in by the grand jury against Wm. David Welter and John D. Hendershott of wilfully murdering Wm. Hendershott on Dec. 14, 1894. The prisoners were then brought into the court room. They were requested to stand up. The clerk of assize read the indictment and they were asked individually if they were guilty or not guilty. Both prisoners answered in a clear and firm voice that they were not guilty. They were then asked if they were ready for trial. They replied that they were.

The trial will start at 1:30 tomorrow.

NEWFOUNDLAND'S CRISIS. Its Real Cause Explained to England by

Sir William Whiteway. LONDON, March 6.—Sir William Whiteway, Prime Minister of Newfoundland, has cabled a letter to the Times, complaining of the misrepresentations in regard to Newfoundland's finances made in the English press. He declares that the decline in the revenues in January and February were attributable to causes other than the financial crisis, such as reduced purchasing power, owing to the limitation of the market for exports. This, he says, would have been materially averted had the Imperial Government ratified the Bond-Blaine Convention, which he considers it was morally bound to do since it had authorized further negotiations.

The absence of the United States markets for Newfoundland's exports and the complications arising from the imperial recognition of the French fishery claims, contributed largely to the crisis. Continuing, Sir Wiliam says:

"The spirit of the Newfoundland people is apparently little understood. I believe they would starve rather than surrender their independence. The descendants of the Newfoundland fisher-men who manned the fleet which gained Great Britain her maritime supremacy are naturally embittered to see that fleet now employed to drive them from the fisheries-theirs by right of birth-

for the accommodation of Frenchmen. After referring to the fact that the Government has not yet responded to Newfoundland's request that it guarantee the interest on its debt in order to tide the colony over its difficulties, Sir William concludes by saying that if the colonists must still trust to their inherent pluck and the resources of the country, they must only passively submit, although they may more bitterly feel their heartless treatment by the Imperial Government.

AFTER THE BATTLE.

Results of the Attempted Bank Robbery at Des Moines.

DES MOINES, Ia., March 6.—At Adele, the county seat of Dallas county, 22 miles from here, the bold bank robbery this morning was followed by the oursuit of the amateur bandits, the killing of one, and the formation of an angry mob, which surges about the county jail tonight and threatens to have the life of the surviving robber. The funds of the bank were saved by the presence of mind of the cashier, who after being shot closed the door to the vault and turned the combination. Following are

THE CASUALTIES: Dead-Orlando P. Wilkins, robber, from Patterson, Madison county Ia., aged 30, shot by pursuers.
Injured—S. M. Leach, cashier of the bank, seriously injured in the left shoulder and neck; C. D. Bailey, merchant, shot in the shoulder; J. M. Byers, prominent citizen, shot in hand and arm; R. S. Barr, postmaster, shot in the left arm; J. L. Simpson, citizen, and Cecil Dexter, a boy, slightly wounded.

The robbers, Orlando P. Wilkins and C. W. Crawford, were farmers living in Patterson. They entered the bank just as Cashier Leach was taking the money from the vault. Wilkins fired at Leach, who staggered, but recovering he flung the currency and gold on the counter into the vault and closed the door. Wilkins fired again, wounding Mr. Bailey. The robbers then scooped the loose silver into a sack. It amounted to \$267. By this time Sheriff Payne arrived and opened fire on the robbers, who made a rush for their buggy, Wilkins firing as he ran and wounding the other citizens mentioned. The robbers started to drive across the country. They were hotly pursued, and after a chase of twelve miles their wounded horses could go no further. Crawford secreted himself in a clump of timber, but was soon sur-rounded and surrendered. Wilkins took refuge in a barn. To repeated orders to come out he made no reply. Then Crawford was forced to saturate a straw stack near the barn with kerosene and start a fire. When the flames closed about Wilkins, he made a rush across the open space for the timber, but soon fell, wounded by a bullet from a rifle.

Then the mob lost control of itself, and the robber was riddled with bullets. The corpse of Wilkins and his living companion were later taken back to Adele, where, this afternoon, Crawford made a full confession. He claimed that had been forced into the job by Wilkins, who threatened to kill him if his nerve

weakened. Tonight the biggest crowd ever seen in Adele is upon the streets there. Every man carries a rifle, shotgun, pistol or club. Sheriff Payne has the jail protected by a large and well-armed posse All the wounded are doing well

Belmore.—Will I have to work from date to date if I hire for seven months, or is 26 days a legal month? Ans .-

From date to date. Bothwell.-A man is assessed on the last revised assessment roll for \$800 as president of a company. Can be qualify for reeve or councilor in said village? Ans.—No; the company is assessed, not the man, who is neither owner nor ten-ant of the property.

School Janitor.—Can a son or sons of a public school trustee act as janitor of said school legally? Ans.—Yes; but the trustee vacates his seat if he has or expects any profit, interest or benefit from the employment of his son or sons. See section 191 of School Act of 1891.

Thedford.—A dies without a will leaving two children and a wife. It there be no settlement while the mother lives will each child share alike? The eldest takes everything that is made on the farm during the mother's lifetime. Ans.-Each child shares alike. The eldest can only legally take his share, which is one-third of the whole.


