Mr. Speaker reported that when the House did attend the Honourable the Deputy Governor General in the Senate Chamber, His Honour was pleased to give, in Her Majesty's name, the Royal Assent to the following Bills:

Bill C-44, An Act to amend the Senate and House of Commons Act, the Salaries Act and the Parliamentary Secretaries Act.—Chapter No. 44.

Bill C-34, An Act to amend the Farm Credit Act.—Chapter No. 45.

Bill C-367, An Act to amend the Fort-Falls Bridge Authority Act.—Chapter No. 46.

Debate was resumed on the motion of Mr. Sharp for Mr. Turner (Ottawa-Carleton), seconded by Mr. Faulkner,—That Bill C-58, An Act to amend the Income Tax Act, be now read a second time and referred to the Standing Committee on Broadcasting, Films and Assistance to the Arts.

Bill C-19, An Act to provide for payments in respect of wheat produced and sold in Canada for human consumption in Canada was read the third time and passed.
