### INFANT DEATHS

#### Mr. Enfield:

Is any federal assistance being given for research into the causes of infant deaths in Canada?

Mr. Robertson: Yes, under the national health grants program payments have been made on projects approved amounting to over \$52,600.

These research projects include one in Toronto and one in Winnipeg to study the causes of stillbirths and the deaths of newborn infants. The departments of obstetrics and pathology of the University of Toronto, and the research institute of the Hospital for Sick Children are collaborating in the study in Toronto. In Winnipeg the research is under the supervision of the department of pediatrics of the University of Manitoba.

#### FLUORIDE

### Mr. Proudfoot:

Has it been definitely proved that one part per million of fluoride in a water supply will help to prevent tooth decay?

Mr. Robertson: Yes, to the extent of about 65 per cent. This has been proved by research studies carried out in Canada and in the United States, including one conducted by the Department of National Health and Welfare over the past eight years working in co-operation with the departments of health of the province of Ontario, Brant county, Lambton county, and the city of Stratford.
