EL SALVADOR—POSITION OF CANADIAN GOVERNMENT— MOTION UNDER S.O. 43

Mr. Ian Deans (Hamilton Mountain): Madam Speaker, on this important day, the seventy-third birthday of the hon. member for Winnipeg North Centre (Mr. Knowles)—

Some hon. Members: Hear, hear!

Mr. Deans: —I want to place before this House a motion which has absolutely no relationship to that, but one I am sure will gain the support of everyone. Today there will be a petition placed before the House on behalf of 4,000 persons from the area of Hamilton, with regard to El Salvador.

We, as members of Parliament, know that all Canadians are saddened by the knowledge that for hundreds, perhaps thousands, of innocent people living in El Salvador the proposed
