if this treaty is to come into force, it will have to give away the Yukon fisheries?

Hon. John A. Fraser (Minister of Fisheries and Oceans): Mr. Speaker, the Hon. Member, who is from the West Coast, is better at making statements than he is at reading the text of the treaty. The treaty does not say that Canada and the United States have to enter into an agreement on the Yukon River. What it does say is that both sides will set a range to establish a beginning of negotiation, and they will then meet in October of this year to talk about the Yukon River. The difficulty is that my hon. friend keeps confusing the setting of a range of fish available to either country as a beginning to negotiations with that of a commitment to settle the matter, when it cannot be settled without the negotiations the treaty clearly implies.

DECISION TO CUT BUDGET FOR HOUSING RENOVATION PROGRAM

Last week, spokesmen for the housing co-operative societies of the Greater Montreal area staged a sit-in in the office of the Hon. Member for Verdun-Saint-Paul, to protest the \$4.5 million cut announced by the Minister in the housing renovation program that was related to co-operative housing. Can the Minister tell us whether he is aware that

if he stands by that decision, he runs the risk, first of killing co-operative housing in the Greater Montreal area and in all Canadian urban centres, and, second, of witnessing a significant rent increase?

Hon. Bill McKnight (Minister of Labour): Mr. Speaker, I would like to thank the Hon. Member for assisting me in clarifying something which may be unclear in his mind and in the minds of his constituents. There has been no decision made by the corporation on the disposition of non-profit RRAP to which the Hon. Member refers. It is included, along with other programs, in the study that this Minister and the corporation are doing. I would also suggest to the Hon. Member that the decisions made by a Crown corporation are not decisions made by a Minister.
