CUBA WILL QUIT OFFICE AT HALIFAX

Will Give Local Port Added Status in Trade FUTURE BRIGHT

Nova Scotia Officials Register Protest Against Proposed Amalgamation

ABSORPTION of the office of Cuban consul at Halifax by the one in Saint John under the direction of R. C. Betancourt, present consul here, is announced in a recent issue of the official gazette of Cuba, but Mr. Betancourt said he has not received official word directly himself on the subject, although he knew the change was projected.

More Trade Looked For This, he said, gives some idea of the increased trade will mean to this port.

Since taking over the Saint John office here, Mr. Betancourt has thoroughly re-organized it and now has a suite of rooms at 721-2 Prince Street, having moved from Charlotte street. He predicts the volume of trade between the two countries will increase enormously this year and that Saint John will feel the effect of this extra business.

The Cuban consular plans to inspect closely the Saint John exhibition here in his efforts to help the trade relations between the Maritime Provinces and Cuba.

U. S. ENTRY TO WORLD COURT VIRTUALLY SURE

Only Part of One Reservation Now Un-accepted

PARLEY IS ENDED

Conference on Question Is Adjourned Until After League Session

GENEVA, Sept. 4.—The United States reservations to adherence to the world court eventually will be accepted. This was the virtually unanimous opinion of the delegates to the conference which adjourned last night.

NEAR AGREEMENT

The ultimate entrance of the United States into the permanent court of international justice, hinges therefore upon the last half of the fifth reservation.

CLAIM TO INTEREST

This amendment apparently would have permitted the court to decide whether a United States claim to interest in any question referred to the court for an opinion, had basis in fact.

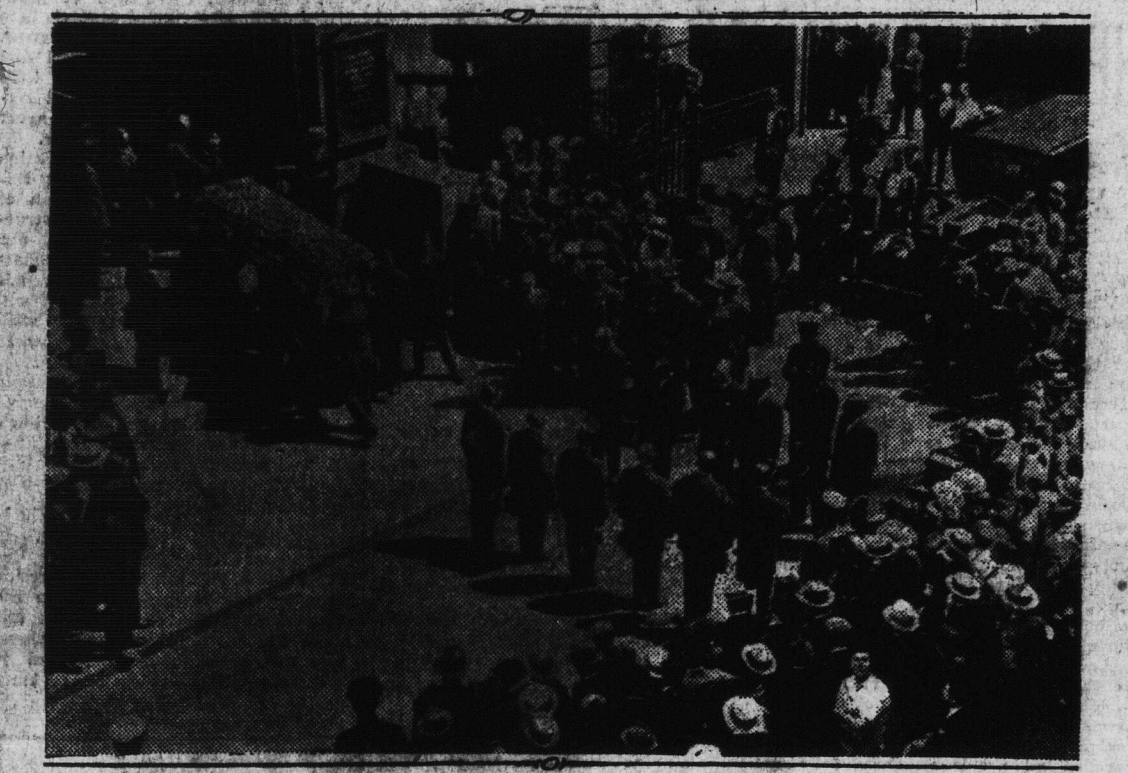
Hold up Automobile in Trenton, N. J., and Get Away With Payroll

AN INQUEST will be held into the circumstances surrounding the tragic death of Mrs. Alister McKiel, who was drowned at West Saint John last night. It was announced this morning by Coroner Dr. F. L. Kenney. A jury will be formed and the body viewed this afternoon, the first session of the inquest probably being held the first of the week.
