

REGISTRAR OF DEEDS, ALBERT, IS DISMISSED

Alexander Rogers, 90, Only Survivor of Provincial House of 1875

OTHER CHANGES IN N. B. ANNOUNCED

David H. Charters Succeeds I. N. Killam as West-moeland Sheriff

FREDERICTON, June 23.—Alexander Rogers, of Hopewell Hill, the only surviving member of the Provincial legislature of 1875, who is now about 90 years of age, has been dismissed from the office of registrar of deeds for Albert county by the provincial government, with effect on July 15, according to notice in the Royal Gazette today.

Horace S. Goddard of Egin, is appointed as his successor as well as successor to William D. Bennett of Hopewell Cape, a judge of probate, Mr. Bennett's dismissal being also gazetted today.

David H. Charters is appointed as High Sheriff for the county of Westmoeland in place of Sheriff I. Newton Killam, whose term of office has expired, with effect on July 1.

APPEALS TO U. S. Honduran Ship Officer Held at Havana on Slaying Charge. HAVANA, Cuba, June 23.—Fritz Gerler, first officer of the Honduran steamer Olancha, held without bail on a homicide charge growing out of the death of William Jones, a British stowaway in Santiago de Cuba last week, has appealed to the United States consul, claiming that he is a naturalized United States citizen. Despatches from Santiago report that the consul has taken the matter up with the State Department at Washington. Jones was asphyxiated when locked in a storeroom on the Olancha.
