And for the Encouragement and Encrease of Private Ships of War, Be it further Enaded, Chat the Lord High Lomiral of Great Britain, or the Commissioners for Executing the Office of Lord Diah-Admiral of Great Britain for the time being, or any Person or Persons in any Part of America, by him or them Impowered and Appointed, thall (at any time during the present War, at the Request of any British Owner or Owners of any Ship or Tessel. aiving such Bail and Security as has been usually taken upon granting Commissions, or Letters of Warque, except only for the Payment of the Tenths of the Calue of the Prizes which shall be taken, to the Lord high-Admiral) cause to be issued forth (in the ulual manner) one or more Commilion or Commilions to any Derfon or Perfons whom such Owner or Owners thall Mominate to be Commander ( or in case of Death successively Commanders ) of such Ship or Aestel, for the Attacking, Surveising, Seifing, and Taking, by and with fuch Ship or Aestel, any Ship or Cellel, Goods, Ammunition, Arms, Stores of War, or Merchandises belonging to or possessed by any of Her Majesies Enemies, in any Sea, Creek, Daven, or River in America, not being within the space of One hundred Leagues of any Part of Alia oz Africa, whereof that Crade is already granted to the East-India Company; And that such Ship or Ships, Uessel and Cessels. Arms, Ammunition, Stores of War, Goods and Werchandizes Whatsoever, with all their Furniture, Cackle or Apparel so to be Caken by 02 with fuch Private Owner 02 Owners, Ship 02 Aeffel, according to such Commission and Commissions, being first adjudged Lawful Prize in any of her Pajesties Courts of Mmiralty in 02 for any of Her Colonies or Plantations in America. thall (subject to the Customs and Duties parable to her Majesty. as aforefaid, for and in respect of such Goods and Werchandises) wholly and intirely belong to, and be divided between and among the Owner or Owners of such Ship or Aessel, and the several Persons which shall be on Board the same, and be Living and Acfisting to the Caking thereof, in such Shares and Proportions as Hall be agreed on with the Owner or Owners of fuch Ship or Aeliel as thall be the Captor thereof, their Agents or Fadors, as the proper Goods and Chattels of luch Owner or Owners, and the Persons that thall be thus Entitled thereto, by Airtue of such Agreements among themselves; and that neither Der Maielly, Der Deirs or Successors, or any Admiral, Aice-Admiral, Governor, of other Person Commissioned by of Claiming under her Waieth, her Heirs or Successors, or any Person or Persons whatsoever (other than the Owner or Owners of such Ship or Uessel, being the Captor of such Prize-Ship or Cessel, Arms. Ammunition, Stozes of War, Goods and Werchandizes, and the Persons Claiming under him or them) shall be Entitled to any Part of Share thereof ( her Pajesties said Duttes and Customs being duly Answered and Paid;) And Eukom, Statute or other Law to the contrary notwithkanding.
