Didn't count papers in wallet, ~~wasn't~~ can't say if all were white but some were. Were 3 of us at small round table, and nearly opposite me. Next morning ascd returned trousers to Franiere. First time I had seen wallet - recognized it by identity card. Saw it for about 3 mins - first time to tear the papers & put wallet back in pocket without the money. Wallet was on table when tearing papers. Zipper went around 3 sides. Picture was facing me when wallet lying on table. Zipper fastener on opposite side of wallet when lying on table. At pay day I was paid a \$1 note

3. Witness DISBOOYS Pte Franiere, A, Fus MR, duly sworn, states:
Proof Betman. Know ascd, Gpl Lagace. I lent my pants to ascd a week end in Aug. He asked for pants to go on pass when on release around 21 October. Pay day was on Fri & this was after. Lent trousers sat noon. I emptied pockets but forgot back pocket which had wallet. I next saw ascd Mon morning when he gave me pants back. At noon Gpl Ray asked me to change some money. I had 2 1/2 notes & some change - I put \$/ change in my pocket & 2 1/2 notes in wallet & put in back pocket. Did not take wallet out of pocket after. Wallet was black with a zipper - had been used about 1 1/2 yrs. Zipper around 2 sides. Had identity card, 8 M stores papers, addresses - 8 M papers white - identity card written on typewriter, not military card. My picture was printed in the card & name was signed by me on it. Clear picture, recognizable 3 to 4' away. Ascd gave pants back Mon morning. Ascd knows who he went away with or where he went. I asked him for my wallet when he gave back pants & he sd he had not seen it.

Cross-exam. Gave back pants Mon morning. He did not give them to me the day he came back. Gave them to me personally. Identity card was type required to work in machine shops in 1940 - white card - given by ministry of works.

Remember previous statement in which I said there was no photo in wallet - I did not mean identity card, but separate photo. After gave ascd pants about 1 1/2 hrs I remembered wallet, someone had ago to sell & when I reached for my wallet it wasn't there & I remembered it was in pants. During the hour went to sport parade, stayed about 15 mins & went back to hut, then noticed wallet gone. Was in hut when I changed pants - went thru 2 side pockets only. Went on parade night after I changed pants, about 1/2 hr after I waited for parade in my hut. It was after parade someone offered me cigs. I don't know who offered me cigs. Had seen paid a few days before - I drew \$1 - he paid me 2 1/2 notes

Re-exam. Was broke when pay day arrived, only had about 12 & 1/2 went away. ~~Pants were returned~~ he was in a hurry. Court. Lent pants on Sun near net sat. Got them back the morning after I lent them.
