The said Lords of the Committee have reported as their opinion to His Majesty, that the said Acts should be left to their Operation; His Majesty was thereupon this day pleased, by and with the advice of His Privy Council, to approve of the said Report, whereof the Governor Lieutenant Governor or Commander in Chief of His Majesty's Island Prince Edward for the time being, and all other Persons whom it may concern, are to take notice and govern themselves accordingly.
