VANCOUVER-REQUEST FOR ACTION ON UNEMPLOYMENT

On the orders of the day:

Mr. Harold E. Winch (Vancouver East): I should like to direct a question to the Minister of Labour. I do so because of the courtesy of the Minister of Transport and the president of T.C.A. in enabling me to spend two days in Vancouver after three months' absence. On the basis of what I saw there I should like to ask the Minister of Labour, in view of the situation in Vancouver where they now say, in the construction industry and in the fisheries, that they are not in a recession but a state of depression, whether he can inform us what action is being taken, if any, to deal with the unemployment situation in that city.

Hon. Michael Starr (Minister of Labour): Mr. Speaker, I am not aware of any such situation in Vancouver as described by the hon. member and have received no representations from anyone in that regard.

[Later:]

Mr. Winch: Mr. Speaker, I wish to direct a supplementary question to the Minister of Labour. Did I understand him to say he had received no information whatever about the situation in Vancouver, and has not yet heard that there is not a recession but a depression in the construction industry?

Mr. Speaker: Order. The hon. member is repeating the allegations which he made in his earlier question, to which the minister has already replied.

Mr. Starr: Mr. Speaker, I wish to say something on this, if I may. I assumed that the hon. member was making reference to some special representations in this regard. According to my recollection no such representations have been made.
