Mr. Forgie: I should like to refer to a short speech I made last September regarding the situation which prevails at Petawawa military camp. I told the minister at that time that I hoped he would investigate the matter to see whether some remedial action could be taken up there to lessen the suffering which is going on there because of the insufficiency of hospital facilities.

A question was asked on this subject the other day by the hon. member for Trinity, on the order paper, and the answer given was most evasive. There is plenty of evidence in *Hansard* and also in the minutes of the proceedings of the committee which dealt with the estimates of the Department of National Defence to warrant some assistance being given at Petawawa. I shall read some of this evidence to the committee. As reported in *Hansard* of 1959, volume V, page 5509, the committee of the whole was considering the following estimate:

230. Grants to the town of Oromocto, subject to the approval of treasury board, for municipal services including the maintenance and operation of schools and to promote the development of the town, \$1,656,000.

At that time the former minister of national defence had this to say:

Oromocto is the dependants' town at Gagetown. It is where all the dependants of personnel and the married service personnel live. It is set up under a special agreement that was reached a few years
