HUDSON BAY-AGREEMENT AS TO UNDERWATER RESOURCES

Mr. André Fortin (Lotbinière): Mr. Speaker, my question is for the Prime Minister.

Does the government intend to approve the agreement concluded some time ago by Ontario, Manitoba and Quebec on dividing lines regarding the underwater resources of Hudson Bay?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the dividing line of those provinces on Hudson Bay has already been defined by a constitutional statute. The line follows the coast of the provinces and there has been no change. The provinces cannot on their own initiative amend the constitutional declaration.

Mr. Fortin: I have a supplementary question, Mr. Speaker.

Since the federal government has not yet endorsed the agreement between those three provinces, does it intend to do so?

Mr. Trudeau: Mr. Speaker, perhaps my answer was too complex. The answer is positively no. The dividing lines have been established and we shall never agree to such a unilateral redefinition by the provinces.
