ALLOCATION OF BOXCARS TO POOLS UPON TAKEOVER OF FEDERAL GRAIN COMPANY ELEVATORS—WAIVER OF NORMAL NOTICE OF SEVERANCE TO EMPLOYEES

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I should like to direct a question to the Minister of Justice as minister in charge of the Wheat Board. In the light of the proposed takeover by the pools of the Federal Grain Company facilities, is it intended that the boxcars which would have been allocated to the Federal elevator system will be turned over to the pool system after the takeover?

Hon. Otto E. Lang (Minister of Justice): The ordinary practice in the event of an exchange of elevators is, I believe, for the portion of the boxcars allocated to those elevators to go along. I expect this will be the procedure in this case. There are some serious questions in relation to congested elevators and particularly facets of the formula, which are under consideration in relation to this recent development.

Mr. Korchinski: Mr. Speaker-

Was a waiver granted by his department?

Hon. Martin P. O'Connell (Minister of Labour): Yes, Mr. Speaker, a waiver was granted early in February of the group termination notice under certain terms and conditions, to which the company agreed, which were deemed to fulfil the intent of the act and in the light of an alternative plan proposed by the company with respect to its employees which in many respects went beyond the provisions of the requirements of the code.
