*REOPENING OF UNEMPLOYMENT INSURANCE COMMISSION OFFICES

Question No. 608-Mr. Rynard:

Does the government propose to reopen the Unemployment Insurance Commission offices in those cities where they were previously closed and, if so (a) will such offices be close to or in the same building as the Canada Manpower Centres (b) what criteria, if any, will be used for the reopening of such offices?

Mr. Mark MacGuigan (Parliamentary Secretary to Minister of Manpower and Immigration): Mr. Speaker, the goal of the Unemployment Insurance Commission is to humanize its services by bringing these services closer to the client population. The matter of opening new Unemployment Insurance Commission offices or of reopening those offices that were in existence prior to 1967 is under continual study as part of this goal.

The answer to sub-question (a) is as follows: The Unemployment Insurance Commission tries to locate its services in the same premises as the Canada Manpower Centres, provided space is available, otherwise the commission tries to establish its facilities as close as possible to the Canada Manpower Centres.

In reply to sub-question (b): The criteria used for the opening of offices are mainly; the numbers and geographic distribution of the claimant population, the availability of adequate transportation and/or parking for clients and; in so far as possible, the commission is trying to use the same area boundaries that are used by Canada Manpower Centres.

Of course, administrative costs have to be taken into consideration, and the availability of properly trained personnel is another factor.

Hon. James Richardson (Minister of National Defence):

1. There are five Boeing 707/347C and 23 Hercules (C130) aircraft with a trans-Atlantic capacity. The Boeings normally carry 157 passengers whilst the Hercules are restricted to freight only on trans-Atlantic flights. As all
