### SUGGESTED BROADCAST TO WARN YOUNG PERSONS OF DANGERS OF GLUE-SNIFFING

**Right Hon. J. G. Diefenbaker (Prince Albert):** Mr. Speaker, I wish to direct a question to the Minister of National Health and Welfare. It arises because of the number of representations that have come to me in connection with the grave danger to physical health and to the brain of those who sniff glue. I would ask whether or not the government has made any decision to have this question brought generally to the attention of the Canadian people by way of a television or radio advertising campaign, to the end that the many young people across Canada who would suffer irreparable harm from this practice will be warned in advance.

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, I thank the right hon. member for having given me notice of his question. The problem he raises is certainly a very serious one which is a cause of concern to all Canadians. It relates not only to glue-sniffing as such but to all kinds of other products that have effects as damaging as glue-sniffing itself. We will certainly carefully study the suggestion made by the right hon. member, but I must say there is a difficulty in this respect in that any advertising or promotion might be counterproductive in this field. We have committees of experts with which we are working to consider the effect of publicity in this field to determine whether it may be counterproductive.

**Mr. Diefenbaker**: Mr. Speaker, I thank the minister for his very complete answer. Just for the purpose of making the Canadian people aware of how terrible the danger is I ask, has there been any census taken with a view to ascertaining the number of young men and women, boys and girls, who indulge in this practice?

**Mr. Lalonde:** No, Mr. Speaker, except for a certain number of tragic accidents of which the public is very well aware.
