Hon. C. M. Drury (Minister of Public Works): Mr. Speaker, I think the hon. member cannot really be serious in his intention when he says he respects my refusal to comment on speculative stories in one respect, but I should take the opportunity to deny another sort of speculative story.

Mr. Broadbent: Mr. Speaker, the minister clearly misunderstood me. I said that I understood from his earlier answers he was not going to tell us in a positive sense what he did say to the judge. He has already said that. I do not accept that answer but I am not pursuing it any longer. The question I am putting to him is, would he at least take the opportunity of clarifying, and I hope denying, that he made any reference to the fact that the Minister of Consumer and Corporate Affairs was a French Canadian and that he was a very important person? Surely, the minister can at least do that, since it is outside his own terms of reference within which he has answered questions in the House before. Why can he not at least deny that?

Mr. Drury: Mr. Speaker, I am surprised the hon. gentleman is falling for the tactic of ascertaining, rather inefficiently, a fact by setting up a series of straw men to be knocked down.
