said it would be, will the minister reconsider the answer he gave yesterday? Can he tell the House, for instance, that the government will consider bringing in a special summer works project that will deal with this extremely high level of unemployment in a serious manner?

Hon. Allan J. MacEachen (Acting Prime Minister): No, Mr. Speaker, I cannot give that undertaking.

UNEMPLOYMENT—POSSIBILITY OF NATIONAL PROGRAM OF RESIDENTIAL INSULATION TO CREATE JOBS

Mr. Edward Broadbent (Oshawa-Whitby): A supplementary question, Mr. Speaker. Considering that the cost of current levels of unemployment to employed Canadians is about \$9 billion per year, some \$2 billion being for welfare and unemployment insurance payments, \$6 billion for lost productivity, the rest being made up of taxes not paid by the unemployed, would the minister consider financing a national program of insulation for residential buildings across the country which has been estimated to cost about \$1 billion? That \$1 billion would provide at least 4,000 additional jobs and be important in conserving energy.

Hon. Allan J. MacEachen (Acting Prime Minister): Mr. Speaker, there is no doubt that the hon. member's proposal has merit. The Minister of Energy, Mines and Resources has already implemented such a program in two provinces and obviously is concerned about its application in all of Canada. The hon. member mentioned that the cost of such program would be \$1 billion per year. At the present time it is not possible to find resources to add to the present budget to finance such a special program, although undoubtedly the suggestion has all the benefits the hon. member says it has.

Mr. Broadbent: A final supplementary question, Mr. Speaker. When we first proposed such an insulation program last September we did not anticipate that even the government would take it up in such a half-hearted way as to apply it to two provinces. We estimated at that time that the savings in energy costs alone to the Canadian economy in the years ahead would justify the capital expenditure. Considering the savings in energy, which are so important to the Canadian economy as a whole, and considering the need to provide jobs early in the summer months particularly for young Canadians, will the minister not make a commitment to go ahead with this eminently sensible program?

Mr. MacEachen: I think it is eminently sensible but not financially possible at the present time, Mr. Speaker.
