Hamilton, Jan. 11 .- At the Wentworth

Assizes yesterday the case of Young vs. Smuck, a breach of promise, was taken up. The action was quite a cause celebre in the county, and during the hearing of the evidence the court room was crowded. The plaintiff, Miss Jennie Young, is a very pretty young woman. She is the daughter of Theo. Young, a well-to-do farmer. The defendant is Dr. J. Wallace Smuck, a young physician, now practising in the county. The action was undefended. While in that city he used to write to her, giving glowing descriptions of how he enjoyed himself, and mentioning that he moved in the most fashionable society. He became enamored of some fair Toronto maid, and subsequently married her. In February, 1892, he wrote Miss Young, asking that she release him, as he had come to a conclusion that they could not be happy together.
