Mace, secretary of the London club—the first for making the alleged false declaration, and Mace "for actively promoting the disgraceful tactics employed," as the executive express it-the executive put the extreme penalty of disqualification forever from playing or taking any part in the game of hockey. BASEBALL.

Chicago, Jan. 28 .- On the eve of the American League meeting to perfect its organization for the coming baseball season, to formally complete the signing of the ten-year agreement, and to turn over in trust to President Johnson the stock of the eight clubs in the league, the American League magnates made a public statement last night. It deals with the causes and conditions which led to the present strained relations between the American League and National League. President Ean Johnson stated last night that he had written Nick Young, of the National League, telling him why the National League must ask modifications in the National agreement, and gave out the letter sent to the latter, enumerating these reasons. He stated that President Hart of the Chicago club had agreed to present the arguments of the American League at the National League meeting in December. At first it was thought Mr. Hart had not done so. Mr. Johnson asserted that later he found that Mr. Hart had kept his promise, but that the National League had absolutely refused to consider any proposition for a friendly conference.

THE PROPOSED CITY LEAGUE. Prospects are said to be brightening for the proposed city eight-club amateur baseball league. The scheme as at present outlined is that each club should put up a guarantee to be agreed upon, binding them to observe the rules of the league. The schedule, it is proposed, will provide for games up to Aug. 1, after which time the teams standing first and second should play championship games with Hamilton, Toronto, Brantford, Woodstock, Guelph, Thomas or other cities where amateur league exists. The strictly amateur rule, it is suggested, should be enforced. A meeting to further the project is called for tomorrow evenin at the Grigg House.

The clause regarding drafting and sale are stricken out, and one inserted which provides that a player shall not be sold or traded to another city without his consent. 
