#### NAILS

ALLEGED SHORTAGE ON PACIFIC COAST

On the orders of the day:

Mr. H. C. GREEN (Vancouver South): Reports from the Pacific coast indicate a serious shortage of nails there. Can the Minister of Reconstruction and Supply make any statement with regard to the situation?

Right Hon. C. D. HOWE (Minister of Reconstruction and Supply): I have not heard of a shortage of nails in any part of Canada during the past two months.

Mr. FRASER: You have not been around, then; for there is a shortage.

Mr. HOWE: The fact of the matter is that there was a shortage last year, for several reasons, the principal of which was the strike in the steel industry. The limiting factor today is the amount of wire rod that can be devoted to the making of nails. The rod making capacity of Canada is being operated to the fullest extent, and the nail making capacity is being operated to the extent that rods can be made available. I might add that steel rods are being supplemented by aluminum rods, which make a satisfactory nail for some purposes. I have just received from the statistical department a forecast of production which indicates that whereas the production of nails in 1946 was 59,000 tons, production for 1947 is estimated at 72,000 tons, an increase of twenty-two per cent. I can assure my hon. friend that the industry is today operating at the rate of 72,000 tons of nails per annum, which should more than satisfy the requirements of Canada.

Mr. FRASER: How many nails were exported?

Mr. HOWE: There is, and for many months has been, a prohibition against export of nails from Canada.
