#### ADMINISTRATION OF JUSTICE

HAL BANKS-POSSIBILITY OF RENEWING EXTRADITION PROCEEDINGS

Hon. George Hees (Prince Edward-Hast-

ter, Mr. Speaker. As the Secretary of State of the United States, Mr. Rogers, made it very clear in his interview with Senator Fanning that the new United States government is prepared to extradite Harold Banks as soon as the Canadian government makes an application for such extradition, and as the government of Ontario has made it clear it is anxious to have Mr. Banks extradited so that he can face perjury charges and also serve his five-year sentence, is it the intention of the government to make an application to the new government of the United States to extradite Mr. Banks?

Right Hon. P. E. Trudeau (Prime Minister): I think the Minister of Justice would have to answer this question. I have not been in consultation with him on the matter.

Mr. Hees: As the new government has been in office in the United States for some four months, during which time the Minister of Justice has refused to make such an application, is this refusal due to the fear that Mr. Banks might talk about important financial contributions which he made to the Liberal party before he skipped the country to the United States?

Mr. Speaker: Order. The hon. member will recognize that his question is argumentative.

### HOUSING

REQUEST FOR GUIDELINES ON URBAN RENEWAL

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): In the absence of the Minister without Portfolio in charge of housing, may I direct my question to the Prime Minister and ask him whether the guidelines for urban renewal and public housing will be made available to hon. members prior to the discussion of the amendments to the National Housing Act?

Right Hon. P. E. Trudeau (Prime Minister): Not prior to the discussion, Mr. Speaker, although it is conceivable that in his presentation the minister may wish to talk about such guidelines.
