- 1. Yes. The Canada-Saskatchewan Interim Subsidiary Agreement on the Saskatchewan Northlands allocates \$198,000 in DREE funding to the program. The program complements the Canada-Saskatchewan Special ARDA Program.
- 2. (a) As of March 31, 1976, \$39,000 in DREE funds have been authorized; (i) The Development Unit—Economic Development Branch is an office of the provincial department of northern Saskatchewan. DREE funds are not specifically allocated to each group; (ii) See reply to question No. 5,282, 2(a)(ii); (b) As of March 31, 1976, \$22,200 in DREE funds have been authorized; (i) The Green Lake Socio Economic Study is being carried out by Amisk Planning Consultants of Winnipeg, under contract to the provincial department of northern Saskatchewan. The Canada-Saskatchewan Interim Subsidiary Agreement on the Saskatchewan Northlands allocates \$9,300,000 in DREE funding to the Program. An additional \$7,500,000 has been allocated by Transport Canada.
- 2.
