### HOUSE OF COMMONS

PRESENCE OF PHOTOGRAPHERS IN CHAMBER

Hon. Erik Nielsen (Yukon): Madam Speaker, on that point and on a related point, your Honour has no doubt had an opportunity by now to examine yesterday's Hansard concerning the point of order I raised with respect to the presence of still photographers behind the curtains, obviously for the purpose of taking set up photographs of the incumbent in the Chair and another hon. member. At that time I asked that that practice be rigidly prohibited and that the agreement between House leaders be enforced by the Chair. Otherwise, attitudes of hon. members might alter with respect to the continuation of allowing still photographers behind the curtains.

I hope that that kind of incident does not occur again, particularly involving, as it did, the Chair and the hon. member from the government side.

Madam Speaker: It is not clear that the Chair was involved. However, I take the remarks of the hon. member in good note, because, yes, it is true that photographers have been allowed to photograph during the question period and the permission has been extended to important debates. But the importance of debates would only be determined by the Chair itself and there would then be consultation with the leaders of the different parties.

I can assure the hon. member that the agreement between House leaders will be very strictly enforced. The permission was given because hon. members generally agreed. However, they generally agreed to the photographs being taken under certain conditions, and I am doing my best to ensure that those conditions are observed. I can assure the hon. member that the incident yesterday to which he referred will not occur again.

### [Translation]

Hon. Yvon Pinard (President of the Privy Council): Madam Speaker, you indicated just now that photographers were given permission to take photographs in the House. I realize this is still at the experimental stage, that you have consulted with the House leaders and that we will have an opportunity to discuss the matter again in the near future. I

feel that incidents such as those that have occurred within the last two days should be taken seriously, and I hope that if and when we should decide to accept photography in the House, you will be authorized to impose a minimum of decorum so as to prevent occurrences of the kind we have seen here today.

Madam Speaker: What happened today happened in the normal course of the question period. I think the minister will recognize that I did what I could to prevent the hon. member from tabling the documents. I believe the rules of the House were observed today. As for cameras, that is an entirely different matter, and I can assure the minister that I shall try to enforce the rules and conditions we have set on the presence of cameras in the House.
