REQUEST FOR FUNDING GUARANTEE

Mr. Harvie Andre (Calgary Centre): Mr. Speaker, I have a supplementary question for the Minister of State for Fitness and Amateur Sport. What I would like from this Minister, Mr. Speaker, is a guarantee, the kind of guarantee which this Party has given, that the Calgary Olympics will receive the necessary funding, that they will not have to depend upon the Sports Pool Corporation, the bungling of this Minister, or these grits at the hog trough, the pork barrel, who are running the sports pool and costing us millions. Will the Minister make a simple commitment that the Government will guarantee the Calgary Olympics will have the necessary funding, regardless of what happens to the Minister's sports pool?

CANADA SPORTS POOL CORPORATION—FUNDING REQUIREMENTS

There is evidence to indicate that the losses will exceed \$25 million a year. What the Minister does not understand is that he is accountable to Parliament for that money.

REQUEST FOR PARLIAMENTARY INQUIRY

Hon. Jacques Olivier (Minister of State (Fitness and Amateur Sport)): Mr. Speaker, I have just said it again and I shall say it a third time... Pursuant to the Act, we have made a commitment to spend \$10.5 million. We have complied with the Act and we shall continue to do so. Furthermore, as far as job creation is concerned, we are among the governments that have spent the most on job creation for young people. We spent \$1.2 billion! So I do not think Hon. Members should start confusing youth and the sports pool. Youth has never been involved in the sports pool. What you are trying to do is to ... athletes across Canada—

Mr. Speaker: Order.

Mr. Olivier: —You are denying their right to have an income! What you are saying is that we reneged on an agreement made in 1979. Mr. Speaker, we maintain that we have observed and are observing the 1979 agreement. The proof is that we created the Canadian Sports Pool Corporation. We knew right away that if we observed the agreement, it would be easier than having just a lottery.

Mr. La Salle: You are competing with the provinces!

Mr. Olivier: —You will see for yourself that it is not a lottery, it is a sports pool and it is harder to do.
