The Managers have much gratification in being able to state, that the income from every one of these sources has been greater during the last year than during the one preceding, and a growing interest in the Scheme, on the part of the people, is evident from the fact, that 22 Congregations have to a considerable extent augmented their collections. But it must be evident to the Synod, that there is still ample room for increased liberality on the part of the Congregations, for in looking over the collections, it will be found that 8 Congregations contribute as the Annual Collection from each, a sum less than £1,—several being only 10s. each, and one being 7s. 9d.
