**NORTHWESTERN ONTARIO WATER DIVERSION PROGRAM**

Question No. 2,712—**Mr. Penner:**

1. What has been the total cost of a study entitled "A Proposed Water Diversion Program out of Northwestern Ontario into Lake Superior" presented in June 1964, and the six progress reports which have followed up to November, 1968?

2. How much has been spent on this study since November, 1968?

3. What amount of this sum was provided by the federal government and what amount came from the Province of Ontario?

4. Did any other group, organization or private concern make funds available for this study?

**Hon. Otto E. Lang (Minister without Portfolio):** 1. The study entitled "A Proposed Water Diversion Program out of Northwestern Ontario into Lake Superior" presented in June 1964, was not prepared by this Department or by the Department of Northern Affairs and National Resources. No copy of any study or report by this name and with this date is available in this Department.

The six progress reports are those of the co-ordinating Committee on Northwestern Ontario Water Resources studies established in accordance with announcements made by the Prime Ministers of Canada and Ontario in the latter part of 1965 indicating that studies of Ontario's natural water resources and related economic development would be undertaken by each Government; and that these studies would be co-ordinated by a committee representing the two Governments to avoid duplication of effort. Expenditures for the studies done by Canada which are referred to in the six progress reports mentioned in the Question are as follows:

3. What has been the cost of the supporting ceremonies associated with the special display?

4. How many individuals will be directly involved in the showings at "Man and his World", what are their names, what work do they ordinarily carry out within the departments they are associated with and what salary does each receive?

**Hon. Donald C. Jamieson (Minister of Transport):** 1. The total cost of the New Montreal International Airport Exhibit at "Man and His World" has been \$18,622.34.

2. The exhibit is being maintained without cost to the Department of Transport; maintenance and operation is being provided by the "Man and His World" organization.

3. Cost of the ceremony associated with the opening of the exhibit, insofar as the Department of Transport was concerned, was under \$1,000.

4. No Department of Transport personnel are involved in the daily showings at the "Man and His World" display. The presentation is self-explanatory; projectionists and hostesses are provided by the "Man and His World" organization.
