Pursuant to the Order of the Day, the following Petitions were severally read :

Of the Reverend *John Crombie* and others, of the Presbytery of *Montreal*; praying for the redress of certain grievances connected with the subject of Protestant Education in *Lower Canada*.

Of *P. D. Day* and others, of the City of *Montreal*, on behalf of *McGill College* and University; praying for aid.

Of the Reverend *Samuel D. Rice*, of the City of *Hamilton*; praying for the passing of an Act to authorize Trustees of Church Property to lease, mortgage or sell the same for the uses of the Church.

Of *George Barr* and others, of the Townships of *Loughborough* and *Bedford*; praying for aid for the completion of a certain Road in the said Townships.
