The Report of the Librarian on the state of the Library of Parliament, respectfully sheweth :—

That the removal of the Library of Parliament from *Quebec* to *Ottawa* has been effected without loss or any serious amount of injury.

The packing up of the books was commenced, in *Quebec*, on the 28th of September last, and was completed on the 26th of October. The removal took place by means of barges, along the line of river and canal navigation, in order to avoid the delay and difficulties attending transhipments, or exchange of vessels, which would have been incurred
