TARIFF WAR WILL NOT BE PROVOKED

Canada will discuss tariff question with American Tariff Commissioners.

Ottawa, Ont., March 3.—With the olive branch of peace held out on both sides, the representatives of the American tariff board, Messrs. Emory and Pepper, with the United States Consul General, J. G. Foster, Sir Wilfrid Laurier, Hon. W. S. Fielding and other members of the Canadian government, broached the tariff issue at the Bideau Club tonight.

With Consul General Foster, who will act as official chairman of the investigating American tariff commission, the American representatives called on Sir Wilfrid Laurier for a few minutes this afternoon and were cordially welcomed to the Canadian capital.

As has already been stated, the government here does not believe there is anything in Canada's tariff policy which constitutes any undue burden on the American trade.

In the event of such a request being made, it is pretty certain that the government will entertain it only on a basis of securing an adequate return for any lowering of duties.

Since the new tariff came into effect a reduction in duties on Canadian imports into the States has totalled over one million dollars, as compared with what the duties would have been on the same goods if the tariff under the old tariff.

CROSS AN RESIGN

CROSS GIVES REASON FOR TENDERING HIS RESIGN

Cushing Declares He Did Not And Then Reject Premier's Invitation to Re-Enter the Cabinet.

In Statement He States Position That He Did Not Give Premier Rutherford to Understand Would Re-enter the Cabinet—Says Premier Started to Hinting Had Been Asked to Re-Enter Cabinet and Had Accepted Premier Refuses to Make State-

The past twenty-four hours witnessed sensational developments in the political situation unprecedented in the history of Canada and even those in closest touch with the conditions are unable to predict what will occur in the next few days.

As a thunderbolt from a clear sky came the announcement yesterday afternoon that Hon. C. W. Cross had resigned as attorney general, followed by the resignation of Hon. Sydney B. Woods. Hon. Cross gave his resignation in a statement that he had been informed the premier that Hon. W. H. Cushing had been asked to re-enter the cabinet and had accepted. This morning Hon. W. A. Buxton, minister without portfolio, stated for the position of minister of municipalities, tendered his resignation to the premier.
