Today's Opening of the Grand Lodge at Belleville.

Grand Master White's Interesting Annual Address.

A London Man in the Face for the Deputy Grand Master's Chair.

The Collapse of the So-Called Ontario Grand Lodge Officially Announced.

(Special to the "Advertiser.")

Belleville, July 13.—The 41st annual communication of the Grand Lodge of Canada, A. E. and A. M., opened here at high noon today, with a large attendance. Everything has been done by the board of general purposes and the citizens of Belleville to assure comfort to the visiting Masons.

This evening the visitors will be given a trip around the Bay of Quinte, after which a reception will be given in Massasoqua Park.

The election of officers will take place at tomorrow's session. The selection of R. W. Bro. W. Gibson, M.P., D.G.M., for the high office of grand master by acclamation is conceded. To succeed him as deputy the names of R. W. Bro. E. Macdon, Toronto, R. E. Hunterford, London, and J. E. Harding, Q.C., Stratford, are being discussed, each of whom have many friends.

Among the past grand masters present are Daniel Spiry, London; J. M. Gibson, Q.C., M.P., Hamilton; Murray, Hamilton; J. Ross Robertson, M.P., Toronto.

At the opening ceremonies this afternoon, M. W. Bro. R. W. White, Q.C., grand master, presided and thanked the civic reception committee for its courtesy to the visiting Masons.

THE GRAND MASTER'S ADDRESS followed. During the year he had submitted for approval and had read, examined and approved the full revised bylaws of the lodge, and the amendments to the bylaws of 23. There had been a marked improvement in the manner of submitting these bylaws, and his labors had been somewhat lightened thereby. An unusual number of petitions for dispensations for new lodges were presented to him during the year, and he had granted six and refused three. The list of the Grand Lodge showed an increase over any preceding year in its history. For the first time the receipts exceeded \$20,000, and the expenditure was lower than last year's. A very gratifying condition of the lodge throughout the jurisdiction, and a satisfactory increase in both membership and in the number of new lodges.

In regard to the collapse of the so-called Grand Lodge of Ontario, the Grand Master said: "I am very much pleased to be able to report to this Grand Lodge that during the past year (pursuant to the authority granted at our last meeting), such arrangements have been made with the members of the lodge who have actually swept this body out of existence for I trust all time to come. Their charter (granted by the Provincial Grand Master) has been transferred to myself and the grand secretary, as trustees for this Grand Lodge, all warrants issued to subordinate lodges, and all other books and property of this so-called body have been and are being delivered up and are now in possession of this Grand Lodge.
