A Seat Stolen Outright by Conservative Manipulators.

Returning Officer Who Goes Off on Spree Before Returning His Ballot Box.

Toronto Globe. .-

If one method of subverting the will of the people can be more discreditable than another, fraudulent tampering with election machinery is unquestionably the worst. It pollutes representative government at its source. But it is not unnatural that men who have held office for years by deceiving the public should become liable to draw any fine distinctions between securing votes by impossible promises and by stuffing ballot boxes. That was shown by the methods adopted to perpetuate the Conservative regime during the recent election. With the deputy returning officers rests the responsibility of seeing that an election is fairly and properly conducted, that the electors make a free choice between the can-didates in the field. It is unnecessary to point out the importance of the office, or the need of extreme care in selecting thoroughly capable and trustworthy men. But we have had glaring instances of men appointed on account of a conspicuous fitness for the fraudulent work of the Government party. In several polling subdivisions the control of the election machinery was entrusted to men recommended only by a capacity for election frauds, and disclosures have already shown that the discreditable confidence was wisely or cunningly placed. In London, for example, Mr. William Peel, was ap-pointed a deputy returning officer. In accordance with the law he initialed the ballots as he gave them to the voters, identified his initials after the voters returned from the screened compartment, and then deposited the ballots in the box. No ballot was deposited or could be deposited that did not bear his initials, identified by himself. But when he came to count them he rejected 51 ballots cast for Mr. Hyman, the Liberal candidate, on the ground that the initials on them could not be identified.

The fraud was obvious, so much so that a man of peculiar fitness was required to perpetrate it. In Mr. Peel the Government party had such a man and they naturally availed themselves of his services. Not only did he act as deputy and reject 51 votes for Mr. Hyman in the election, but he was employed at unofficial work for three weeks before the con-His election performance did not raise him into sudden fame, for his record had already been established in the Police Court of the city in which he acted as the custodian and guardian of the franchise. 1885, 1 in 1886, 5 in 1887, 2 in 1888, 2 in 1889, 4 in 1890, 1 in 1891, 4 in 1892, 3 in 1893, and 2 in 1894. The assaults, disorderlies and drunks punishable by fine or imprisonment would make total in light sentences of \$135 or about one year in jail. In addition to these there are several records of being bound over to keep the peace, several of commitment for want of security, and several for commitment for The record contains some of threatening life; also trial. cases assault and wounding, assault to do bodily harm and assaulting a police constable. It certainly did not require keen political discernment to know that Mr. Peel was the man for the occasion. In Lisgar the same op-

eration seems to have been performed in a different way. Although no polling booth was more than nine miles from a telegraph station, about two weeks elapsed after the election before the returns were published, Dur-ing the interval a deputy returning officer was in the Morden Hospital recovering from the effects of a spree and ballot-boxes were lying around hotels and livery stables. It was as serted by a disinterested spectator that balloting was still going on a week after the election. Where the deputy went off on a spree before returning the ballot-box and the unused ballots to the returning officer, and where the boxes and ballots were lying around accessible to anyone desirous of perpetrating a fraud, tampering with the vote would be almost

inevitable. In North Ontario the evidence has disclosed balloting after the election.
The official recount showed that in the ballot-boxes of five polling sub divisions the packages containing the ballots cast for the Liberal candidates were strangely at variance with the count recorded by the deputy returning officers after the close of the polls. Ballots had apparently disappeared, and their places had been filled by others marked for Major Mc-Gillivray, the Conservative candidate. The strange ballots bore no evidence of having passed through the hands of voters. They had not been even folded, a precaution the voter never overbooks, and which is, moreover, necessary when putting the ballots through the small opening in the box. They did not bear the initials of the deputy returning officers, although all the other ballots in those five subdi-

visions had been initialed. Only a few strange ballots appeared in each of the five boxes, the total number being 21. If allowed to Major McGillivray they would have changed his minority of 11 into a majority of 31. The county judge rejected the 21 spurious ballots, but, under the law, could do nothing to restore the 21 good ballots stolen from the package marked for the Liberal candidate. That left the fraud still successful, with a majority of 10 for Major McGillivray. In this case the deputy returning officers did their work properly, and the difficulty of detecting and punishing the real criminal will be greatly lessened in consequence. An era of corruption has by no means reconciled the people to election frauds, and no pains should be spared to discover the perpetrators, that their punishment may be an effective warning to others. petrators, that their punishment may, be an effective warning to others.

RIOTING IN CLEVELAND

Serious Trouble Between Workmen-

Bloodshed-Troops Called Out. Cleveland, Ohio, July 15,-Another riot is in progress at the Brown hoisting works this morning. A number of non-union men have been beaten, stabbed and kicked. Troops will be called out at once.

TO STRENGTHEN ASPHALT PAVING Big Sheets of Expanded Steel Inserted in

the Concrete Base. A novel experiment in street paving is about to be made in South Park avenue, between Sixty-third and Sixty-sixth streets.

Some time ago an inventive genius Some time ago an inventive genius produced what is called "expanded steel." This is simply a thin sheet of metal with slits cut in and expanded lengthwise by forcing these slits into diamond-shaped apertures. It was at first used only as a substitute for lathing in the construction of buildings, but now it is to become part of a new method of laving as part of a new method of laying asphalt pavements, and will be given its first trial on South Park avenue. It is proposed to have steel sheets of one-half inch in thickness cut into large-sized strips and then expanded under powerful pressure. These sheets will be inserted flatways in the concrete base by first laying four or five inches of the stone and cement mixture, and then covering the entire surface with steel, and over this steel in turn will be put the rest of the concrete. When partly dry the base will be compressed by ten-ton rollers and the concrete mixed forced into the interstices in the steel sheets, the whole, when solidly set, forming a foundation which will not only afford a much greater weight-resisting surface than the old system of asphalt paving, but furnish as well an effectual barrier to the picks and axes of

the vandals. Damage to the top coating of an asphalt pavement causes but small expense, or annoyance nowadays. Time was when repairs to the top could only be made by tearing up a good-sized section of the pavement and relaying it entirely, and even then the job was seldom satisfactorily done, as it was almost impossible to get an even surface on the patch.

Now, when the top coat needs fixing a man comes along with an ingenious gasoline contrivance, something on the principle of a plumber's blow-furnace, except that it is mounted on wheels. He shoves it along over the spot to be repaired, and the fierce heat, directed downward, quickly softens the asphalt so it can be readily smoothed over by the rolling machines or hand weights, and an even surface secured. fame, been lit is only when the base or founda-tion of the pavement is cut through

or disturbed that trouble is now found in replacing an even surface.
