PRINTING AND STATIONERY

ADVANCES TO KING'S PRINTER FOR PURCHASE OF MATERIALS

Hon. PAUL MARTIN (Secretary of State) moved the second reading of bill No. 245, to amend the Department of Public Printing and Stationery Act.

Mr. GRAYDON: I suggest that the minister ought to give us a full explanation.

The auditor general has had to call the attention of the king's printer to the fact that he was spending an amount greater than that on hand. All we are doing is to put into legislative form something that is now provided for by order in council.
