Hon. E. J. Benson (Minister of Finance): No, Mr. Speaker, and I wish that some of the provinces who are receiving the money would make sure that the people who are insured get it.

Mr. Hales: A supplementary question. Would the minister advise the House whether the social development tax was imposed for the purpose of paying for medicare?

Mr. Benson: No. Mr. Speaker.

Mr. Louis-Roland Comeau (South Western Nova): Mr. Speaker, you will rejoice at the fact that you have not heard this question for about nine months. Hon. Arthur Laing (Minister of Public Works): Mr. Speaker, we were afraid at one time that the ship would be ahead of us. There is now some suggestion that we will be ahead of the ship.
