REQUEST FOR DEPORTATION OF CERTAIN GYPSIES WHO ENTERED CANADA IN APRIL

Mr. Craig Stewart (Marquette): Mr. Speaker, my question is for the Minister of Manpower and Immigration. Can the minister now report to the House on my question yesterday requesting the deportation of a group of gypsies who are presently victimizing people in western Canada?

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, as a result of the hon. member's representation an investigation has been started into this matter. I might draw to his attention, however, that the gypsy families recently examined, I believe on May 7, in Montreal have already been ordered deported and have appealed to the Immigration Appeal Board; therefore the matter, for the time being at least, is out of my jurisdiction. If the investigation now under way reveals that our national interests would be best served by their prompt removal from Canada, all I can and will do is to recommend to the appeal board that priority be given to the hearing of their appeals.

Mr. Stewart (Marquette): Mr. Speaker, my supplementary question is directed to the Solicitor General. Has the Solicitor General requested the Minister of Manpower and Immigration to have this band of gypsies deported, as they impose a heavy demand on the RCMP in having to tail them back and forth across Canada?

Hon. Warren Allmand (Solicitor General): Not to my knowledge, Mr. Speaker, but I will check it out.

Mr. Andras: Mr. Speaker, on a point of order, when an appeal is made, due process of law has to take place and I cannot interfere.

The quota regulations are good and desirable regulations, and the fact that at a later time in a given quota the year may become open is no ground for a blanket policy.
