**Mr. Deputy Speaker:** I take it there is no question about the propriety of the subamendment?

**Mr. Atkey:** Mr. Speaker, I rise on a point of order. In my haste to draft the motion before you I think I did make one minor error. Rather than coming back with a further sub-subamendment it might be in order for me to provide Your Honour with the correction at the present time. May I proceed?

**Mr. Deputy Speaker:** Yes.

**Mr. Atkey:** The corrected subamendment would read as follows:

That the proposed amendment of Mr. Guay (Lévis) to Motion No. 3 be amended by deleting the first three lines of paragraph (a) of the amendment and substituting the following:

(a) striking out the following words and numbers appearing in lines 1 to 13 inclusive—

With respect, Mr. Speaker, as the hon. member suggested, I think I am going to have to eat some crow. I think my original version is correct.

**Mr. Deputy Speaker:** As I read the hon. member's writing that is right. The last lines refer to lines 1 to 13 inclusive at page 9 and lines 23 to 28 inclusive at page 11. I do not know that there are copies available to other members, but I was going to ask whether hon. members wished this matter reserved in order that the amendment could be typed out and circulated. I am in the hands of the House.

**Mr. Lang:** Mr. Speaker, we have discussed this matter and we are agreeable to proceeding with the proposed subamendment. We are agreeable to the change.

**Mr. Leggatt:** Likewise, Mr. Speaker, we have discussed this proposal with the hon. member and we are happy to support the amendment.

**Mr. Deputy Speaker:** Is the House then ready for the question on the subamendment proposed by the hon. member for St. Paul's?

**Some hon. Members:** Question.

**Mr. Deputy Speaker:** Is it the pleasure of the House to adopt the said amendment proposed by the hon. member for St. Paul's?

**Some hon. Members:** Agreed.

Subamendment (Mr. Atkey) agreed to.

**Mr. Deputy Speaker:** The question now is on the amendment proposed by Mr. Guay (Lévis). Is it the pleasure of the House to adopt the amendment as just amended?

**Some hon. Members:** Agreed.

Amendment (Mr. Guay, Lévis) agreed to.

**Mr. Deputy Speaker:** We now move to the main motion standing in the name of the right hon. member for Prince Albert (Mr. Diefenbaker). Is it the pleasure of the House to adopt that motion as amended within the last few minutes?

**Some hon. Members:** Agreed.

Motion No. 3 (Mr. Diefenbaker) as amended agreed to.

**Mr. Lang:** Mr. Speaker, I should like to ask the indulgence of the House in respect of a total of six procedural matters. First of all, I would seek the consent of the House to the withdrawal of motion No. 11 which deals with this same section. It was designed to correct a typographical error and is clearly no longer necessary. That motion went to division and was, as the hon. member for Winnipeg North Centre (Mr. Knowles) quite properly described it, footless or functus.

**Mr. Knowles (Winnipeg North Centre):** "Functus" was the word I used.

**Mr. Lang:** I would ask for the consent of the House to the withdrawal of motion No. 11 standing in my name.

**Mr. Deputy Speaker:** The House has heard the suggestion of the hon. Minister of Justice (Mr. Lang) that motion No. 11 be withdrawn. Is this agreed?

**Some hon. Members:** Agreed.

Motion No. 11 (Mr. Lang) withdrawn.

**Mr. Lang:** Mr. Speaker, I have four amendments of a consequential nature designed to change those portions of the act which deal with "permit". They ought to refer to "authorizations" under Section 178.15(2). With your leave, Mr. Speaker, perhaps I might move all four motions.

Mr. Speaker, I move, seconded by the Minister of Labour (Mr. Munro):

That Bill C-176 be amended by striking out line 12 on page one and substituting the following:

'given under section 178.13 or subsection 178.15(2);'

Second, I move:

That Bill C-176 be amended by striking out line 38 on page two and substituting the following:

'with any such authorization;'

Third, I move:

That Bill C-176 be amended by striking out

(a) lines 10 to 14 on page 15 and substituting the following:

'(b) authorizations given under section 178.15 for which peace officers to be named in the report who were specially designated by him for the purposes of that section made application,' and

(b) lines 29 to 32 on page 18 and substituting the following:

'(b) authorizations given under section 178.15 for which peace officers specially designated by him for the purposes of that section made application,'

Fourth, I move:

That Bill C-176 be amended by striking out line 37 and 38 on page 17 and substituting:
