whether the government is prepared to reimburse the Canadian Wheat Board for such demurrage charges incurred through no fault of the board or of the western grain producers?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, the question of when demurrage charges are payable depends on a number of circumstances. We do not ordinarily attempt to step in and offset a specific problem in this regard in this industry or any other, and it would be a serious question of principle for us to do so.

EMERGENCY ACTION BY RAILWAYS TO OVERCOME BACKLOG IN MOVEMENT OF GRAIN

Mr. Les Benjamin (Regina-Lake Centre): Mr. Speaker, I have a supplementary question for the Minister of Transport further to that asked by the hon. member for Vegreville. In view of the fact that some \$600 million in grain exports are in jeopardy and that the railways are 11,000 carloads behind at Vancouver and 7,000 behind at Thunder Bay, can the minister say whether the railways are now taking or have they informed him of any emergency priority action they will be taking in an effort to catch up on this backlog?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, a new idea proposed at the conference I attended yesterday was—it was suggested, I think, by the right hon. member for Prince Albert the other day—to have somebody who is going to supervise all this and see whether the best use is being made of the cars. I propose to suggest to cabinet that we implement as soon as possible some kind of monitoring system so that we are sure that all cars are used to the fullest extent at this moment.

The Chair will recognize the hon. member for Regina-Lake Centre for a further supplementary, after which the Chair will complete the first round of questioning by recognizing the hon. member for Champlain and then return for supplementaries to the right hon. member for Prince Albert and the hon. member for Assiniboia.

SHORTAGE OF BOXCARS TO MOVE GRAIN—SUGGESTED PLACING OF ENTIRE RAILWAY SYSTEM UNDER PUBLIC OWNERSHIP

Mr. Les Benjamin (Regina-Lake Centre): Mr. Speaker, my question is for the Prime Minister. In view of the recurring situation in our transportation system, in view of the statement made by the Minister of Transport last Thursday in which he said that the principle of competition in the National Transportation Act is wrong in Canada and that the government does not have a real transportation policy, to use the minister's words, and in view of the present emergency situation, will the Prime Minister advise whether the government will now adopt and announce a policy of taking the entire national railway system in Canada under public ownership and control.

Some hon. Members: Oh, oh! [Mr. Benjamin.]

Mr. Benjamin: —so that the principle of the provision of adequate railway services will be the first priority rather than competition and profit?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, this seems to be an interesting proposition. Perhaps the hon. member could give me details of his suggestion. Would it include, beyond the railways, the bus systems and other forms of local transportation or would it only apply to the railways? If the hon. member can work it out, perhaps he might want to write to me about it.
